The Department supports practical experience internships for professional, full-time work performed in an architectural, engineering, landscape architecture, digital design, visual art and design, or planning office; a library, museum or gallery; or work directly related to a visual art, architecture, design or building technology project.

- The work must be performed for a minimum of **four weeks** during the **IAP** term and **six weeks** during the **summer** term between the first year of enrollment and graduation.
- 4.090 (undergraduate)/4.190 (graduate) can be repeated for credit twice: two summers and one IAP internship or two IAP and one summer internship. If taking **Thesis CPT**, students register for **4.THU or 4.THG** instead.
- International students may not be eligible for a CPT internship if they have reached their total credit
 requirement for their specific degree program unless the internship is directly related to their thesis. If you are
 eligible for CPT and need to work beyond the required end date of the term, you must apply for Optional Practical
 Training OPT for the remaining time period; the lead time for processing and receiving approval for OPT is
 approximately 3.5 months.
- The internship must be directly related to your degree program research and/or your thesis and be preapproved by your academic advisor (see field below, "How is the internship directly related"; enter a statement specifying how this particular job is integral to your curriculum).
- The final grade will be submitted by your advisor upon review of the final written evaluation report signed by the employer.

Dates of Employment for International Students

- Summer 2024, your internship must occur between the dates of May 23 and August 23, 2024. It cannot start before May 23 and must end by August 23.
- IAP 2025, your internship must occur between the dates of December 21, 2024 and January 31, 2025. It cannot start before December 21 and must end by January 31.

Units

- For IAP internships, six credit units are received upon completion of 4.090/4.190 or 4.THU/4.THG pre-register then register for the IAP term.
- For summer internships, one credit unit is received upon completion of 4.090/4.190 or 4.THU/4.THG — pre-register then register for the summer term.
 (units are reduced for summer term to avoid having students pay the higher summer tuition)

Grading

Grades are contingent upon a positive employer evaluation. Please have your employer submit **summer** <u>evaluation forms</u> to Tonya Miller, <u>miller t@mit.edu</u>) or Paul Pettigrew, <u>paulpett@mit.edu</u> for IAP internships by the following dates:

- Grades for summer term must be submitted by the last week in August, so evaluations are due from your employer no later than August 21, 2024.
- Grades for the IAP term must are submitted at the end of January so evaluations from your employer are due by January 20, 2025.
