This list of pre-approved electives will be posted in the upper right-hand corner of the [Classes](#) section of the website. This is the list of courses that have been reviewed and approved as counting towards specific discipline requirements. Course numbers outside the normal list of subjects are reviewed each semester, so taking one of these course numbers a different term does not automatically mean it was approved towards a specific discipline requirement.

A Few More Reminders:

1. All petitions for Alternate Coursework or [Curriculum Adjustments](#) must be submitted prior to the start of your PENULTIMATE semester. **Students on the Feb 2027 degree list = this is your last opportunity to submit.**
2. All petitions for Alternate Coursework or [Curriculum Adjustments](#) to be reviewed for the Spring 2026 term must be submitted to ARCH@MIT.EDU by 9am on Monday, February 2, 2026.
 - a. This includes all supporting materials and forms. Review what is required on the website [here](#).
 - b. This takes a significant amount of time to prepare, so late submissions (where eligible) will be held until the next term.
 - c. Petitions for COMP/HTC Elective courses taken prior to fall 2025 to count towards COMP/HTC Restricted Elective courses will not be reviewed.
